

Team Requirements and the Assumption of the Risk and Waiver of Liability Relating to Coronavirus/Covid-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

The health and well-being of our staff and Participants remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and Participants scheduled to participate to be in our Facilities, parents wishing to remain on site can use outdoor common areas or the parking lot to wait for their Participant(s). Participants waiting to attend a session will need to wait outside while maintaining social distance from others.

MAVA, LLC; MidAmerica Sports Center, LLC and RPG, LLC (hereafter referred to as the "Club") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in Club's facility environment; however, the Club cannot guarantee that you or your player(s) will not become infected with COVID-19. Further, attending sponsored activities at the Club could increase your risk and your player(s)'s risk of contracting COVID-19.

Furthermore, all Participants in sponsored activities at CLUB must agree to and abide by the following:

- Stay home if you exhibit any illness symptoms or simply don't feel "well"
- Stay home if someone in your family is ill
- Must have temperature taken upon entering building, and if above 100.4 degrees will not be allowed to enter
- Coaches must sign a waiver
- Coaches must wear a mask
- Coaches must obtain a signed waiver for all players
- Coach and players must maintain social distances of 6 feet
- Coach and players must abide by all Facility Guidelines posted throughout the Facility
- Must practicing proper hand washing / sanitizing after contacting surfaces inside the building
- Must be logged in for contact tracing purposes upon entering building
- Must wear a face mask upon entering and leaving the building, but not during athletic activity

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and agree to inform my player(s) and their parents/guardians of same risk that I and they may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that I am responsible for informing my players and their parents/guardians of the risk of becoming exposed to or infected by COVID-19 at the Club that may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families. I voluntarily agree to sign and obtain signatures from all of my player's parents/guardian that acknowledge their and my assumption of the all of the foregoing risks and acceptance of sole responsibility for any injury to my player(s) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my player(s) may experience or incur in connection with my player(s)'s attendance at the Club or participation in Club programming ("Claims").

I will sign and obtain signatures from my player(s)'s parents/guardians for the release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree to obtain the same from my player(s)'s parents/guardians that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club activity.
